On October 10 the Planning and Zoning Commission recommended approval of the request to consider amending the Comprehensive Zoning Ordinance to allow new boat sales as a conditional use in the commercial zoning classification. The minimum conditions for such a use that have also been recommended by the Commission are as follows:

- The area to be used for outside display, or storage shall not exceed 50% of the total lot 1. area within 100 feet of any adjacent street.
- All such outside display or storage areas must be permanently paved to City standards. 2.
- 3. All such outside display or storage areas must be screened along all road frontages with a solid evergreen landscape screen a minimum of three feet in height.
- 4. All such outside display or storage areas may be lighted with directed exterior lighting that does not glare onto any adjacent roadways.
- A site plan and landscaping plan shall be submitted in conjunction with an application. 5.
- Such uses shall only be permitted along Interstate 30 and other arterials, as identified on 6. the City's Thoroughfare Plan, but shall be excluded within the Scenic Overlay District along FM-740.

At the worksession the Commission indicated that you would like to consider such a change only with some minimum conditions that would apply to all requests. I have listed several conditions that you might consider as follows:

- a. The area to be used for storage shall not exceed 50% of the total lot area within 100 feet of any adjacent street.
- b. All such storage areas must be permanently paved to City standards.
- c. All such storage areas must be screened along all road frontages with a solid evergreen landscape screen a minimum of three feet in height.
- d. All such storage areas may be lighted with directed exterior lighting that does not glare onto any adjacent roadways.
- e. A site plan shall be submitted in conjunction with an application.
- f. Such uses shall only be permitted along Interstate 30 and other arterials, as identified on the City's Thoroughfare Plan, but shall be excluded within the Scenic Overlay District along FM-740.

Many of these conditions are included in the Highway Commercial district for display of large inventory items. We can discuss these Thursday night. Please note that in addition to any minimum conditions that you might include an application might warrant other conditions on a case by case basis.
