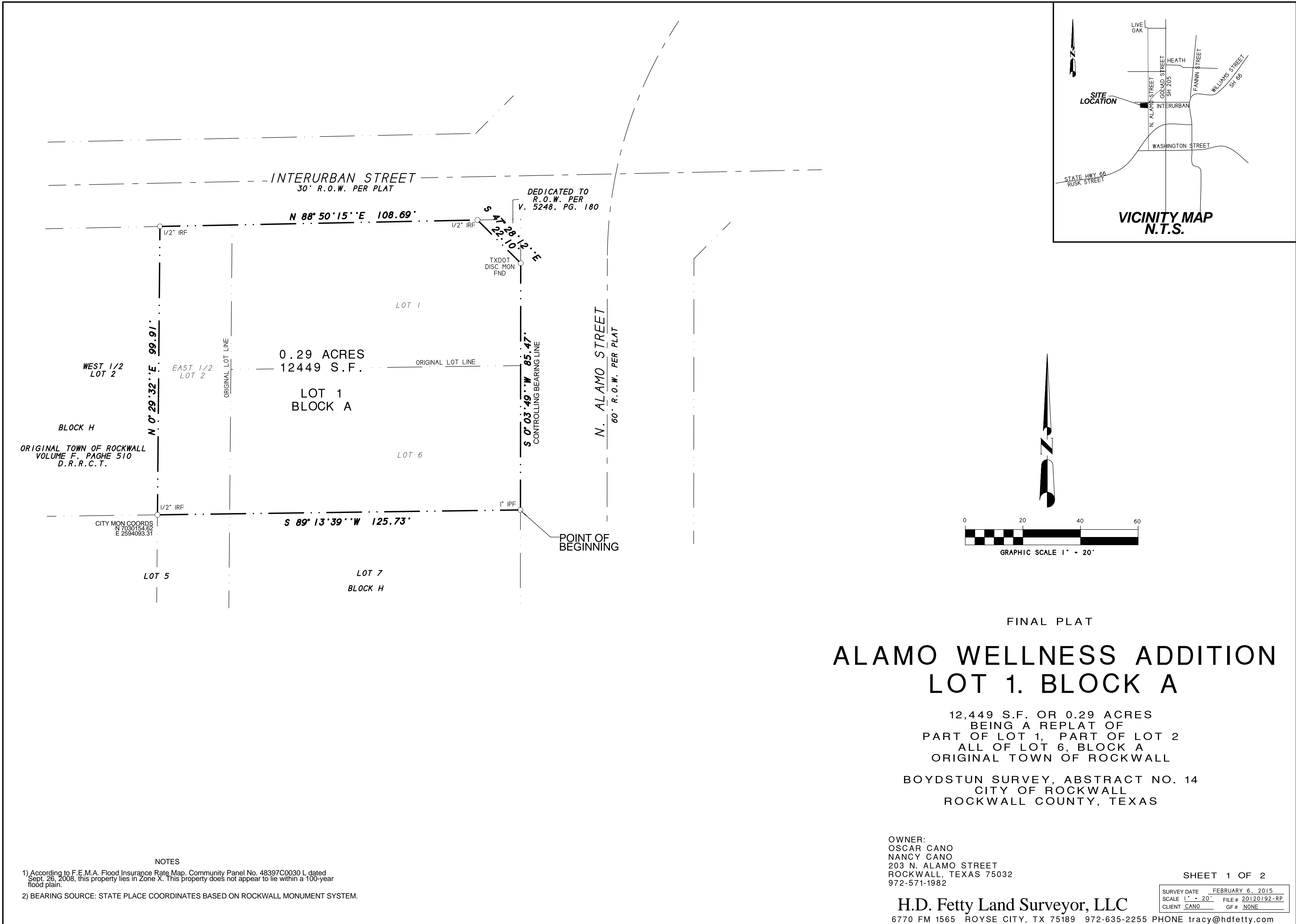

(Public Dedication)

WHEREAS, OSCAR CANO and NANCY CANO, BEING THE OWNERS OF A TRACT OF land in the BOYDSTUN SURVEY, ABSTRACT NO. 14, County of Rockwall, State of Texas, said tract being described as follows:

BEING all of Lot 6, part of Lot 1 and part of Lot 2, Block H, THE ORIGINAL TOWN OF ROCKWALL, TEXAS, according to the Plat thereof recorded in Volume F, Page 510, Deed Records of Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a 1" iron pipe found for corner in the west right-of-way line of N. Alamo Street, at the southeast corner of Lot 6 and the northeast corner of Lot 7, Block H;

THENCE S. 89 deg. 13 min. 39 sec. W, along the common line between Lot 6 and Lot 7, passing the southwest corner of Lot 6 at 100.00 feet, and continuing for a total distance of 125.73 feet to a 1/2" iron rod found for corner;

THENCE N. 00 deg. 29 min. 32 sec. E, across Lot 2, a distance of 99.91 feet to a 1/2" iron rod found for corner in the north line of Lot 2 and in the south right-of-way line of Interurban Street;

THENCE N. 88 deg. 50 min. 15 sec. E, along said right-of-way line, a distance of 108.69 feet to a 1/2" iron rod found for corner at the northwest corner of a tract as described in a Judgement to the State of Texas, as recorded in Volume 5248, Page 180 of the Official Public Records of Rockwall County, Texas;

THENCE S. 47 deg. 28 min. 12 sec. E, along the southwest line of said tract, a distance of 22.10 feet to a TXDOT disc monument found for corner in the west right-of-way line of N. Alamo Street;

THENCE S. 00 deg. 03 min. 49 sec. W, along said right-of-way line, a distance of 85.47 feet to the POINT OF BEGINNING and containing 12,449 square feet or 0.29 acres of land.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

We the undersigned owners of the land shown on this plat, and designated herein as ALAMO WELLNESS ADDITION, LOT 1, BLOCK A, an Addition to the City of Rockwall, Texas and whose name is subscribed hereto, hereby dedicated to the use of public forever all streets, alleys parks water courses, drains, easements and public places thereon shown on the purpose and consideration therein expressed. We further certify that all other parties who have a mortgage or lien interest in the subdivision have been notified and signed this plat.

We understand and do hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same.

We also understand the following:

1. No buildings shall be constructed or placed upon, over, or across the utility easements as described herein.
2. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective system on any of these easement strips; and any public utility shall at all times have the right of ingress or egress to, from and upon the said easement strips for purpose of construction, reconstruction, inspecting, patrolling maintaining, and either adding to or removing all or part of their respective system without the necessity of, at any time, procuring the permission of anyone.
3. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasional by the establishment of grade of streets in the subdivision.
4. The developer and subdivision engineer shall bear total responsibility for storm drain improvements.
5. The developer shall be responsible for the necessary facilities to provide drainage patterns and drainage controls such properties within the drainage area are not adversely affected by storm drainage from the development.
6. No house dwelling unit, or other structure shall be constructed on any lot in this addition by the owner or any other person until the developer and/or owner has complied with all requirements of the Subdivision Regulations of the City of Rockwall regarding improvements with respect to the entire block on the street or streets on which property abuts, including the actual installation of streets with the required base and paving, curb and gutter, water and sewer, drainage structures, storm structures, storm sewers and alleys, all according to the specifications of the City of Rockwall; or

Until an escrow deposit, sufficient to pay for the cost of such improvements, as determined by the city's engineer and/or city administrator, computed on a private commercial rate basis, has been made with the city secretary, accompanied by an agreement signed by the developer and/or owner authorizing the city to make such improvements at prevailing private commercial rates, or have the same made by a contractor and pay for the same out of the escrow deposit, should the developer and/or owner fail or refuse to install the required improvements within the time stated in such written agreement, but in no case shall the City be obligated to make such improvements itself. Such deposit may be used by the owner and/or developer as progress payments as the work progresses in making such improvements by making certified requisitions to the city secretary, supported by evidence of work done; or

Until the developer and/or owner files a corporate surety bond with the city secretary in a sum equal to the cost of such improvements for the designated area, guaranteeing the installation thereof within the time stated in the bond, which time shall be fixed by the city council of the City of Rockwall.

We further acknowledge that the dedications and/or exaction's made herein are proportional to the impact of the subdivision upon the public services required in order that the development will comport with the present and future growth needs of the City. We, our successors and assigns hereby waive any claim, damage, or cause of action that we may have as a result of the dedication of exaction's made herein.
