- ² All projects will be reviewed by the Planning & Zoning Commission during the scheduled work session.
- 3. Residential Plats are subject to review by the Parks Board. If Parks Board review is necessary, you are required to attend the meeting. Contact Andy Hesser at (972) 771-7761 after the submission of a preliminary and/or final plat to discuss parkland issues and verify meeting dates.
- 4. City Council reviews all Plats, Zoning, Specific Use Permit, Planned Development District and/or Special Exception applications.
- 5. Zoning, Specific Use Permits and Planned Development Districts require a second reading of the ordinance prior to final approval/adoption.
- 6. If plans are not resubmitted by <u>3:00 PM</u> on this date your case will be denied, and you will be required to resubmit a new development application and fee on the next available submittal date.

NOTE: <u>Minor Plats</u>, <u>Amending Plats</u>, and <u>Administrative Site Plans</u> can be approved by staff and can be submitted at any time. Please contact staff to discuss requirements and procedures for administrative approval.
