STATE OF TEXAS COUNTY OF ROCKWALL OWNERS CERTIFICATE WHEREAS, Billy G. Jones and Gabe Parsons are the owners of a tract of land in the County of Rockwell, State of Texas, said tract being described as follows: BEING a tract of land situated in the Joseph Cadle Survey, Abstract No. 65. City of Rockwall, Rockwall County, Texas, and also being that tract as recorded in Volume 146, Page 811, Deed Records, Rockwall County, Texas, and being more particularly described as follows: BEGINNING at a point on the Northwest line of Interstate Highway No. 30, said point being the East corner of said tract recorded in Volume 146, Page 811, an iron stake for corner; THENCE, S. 41 deg. 25 min. 21 sec. W., along the Northwest line of Interstate Highway No. 30, a distance of 252.20 feet to an iron stake for corner; THENCE, N. 45 dag. 02 min. 21 sec. W., leaving the Northwest line of Interstate Highway No. 30, a distance of 215. 75 feet to an iron stake for corner; THENCE, N. 46 deg. 16 min. 22 sec. E., a distance of 25.96 feet to an iron stake for corner; THENCE, N. 40 deg. 17 min. 42 sec. E., a distance of 226.52 feet to an iron stake for corner; THENCE, S. 45 deg. 02 min. 21 sec. E., a distance of 218.02 feet to the PLACE OF BEGINNING and containing 1.246 acres of land. NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS: That, Billy G. Jones and Gabe Parsons, being owners does hereby adopt this plat designating the herein above described property as Billy G. Jones Subdivision to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance, or efficiency of their respective systems on any-of these right-of-way and easement strips; and any public utility shall have the right of ingress and egress to, from and-upen the said right-of-way and easement strips for the purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishments of grades of streets in this subdivision.
