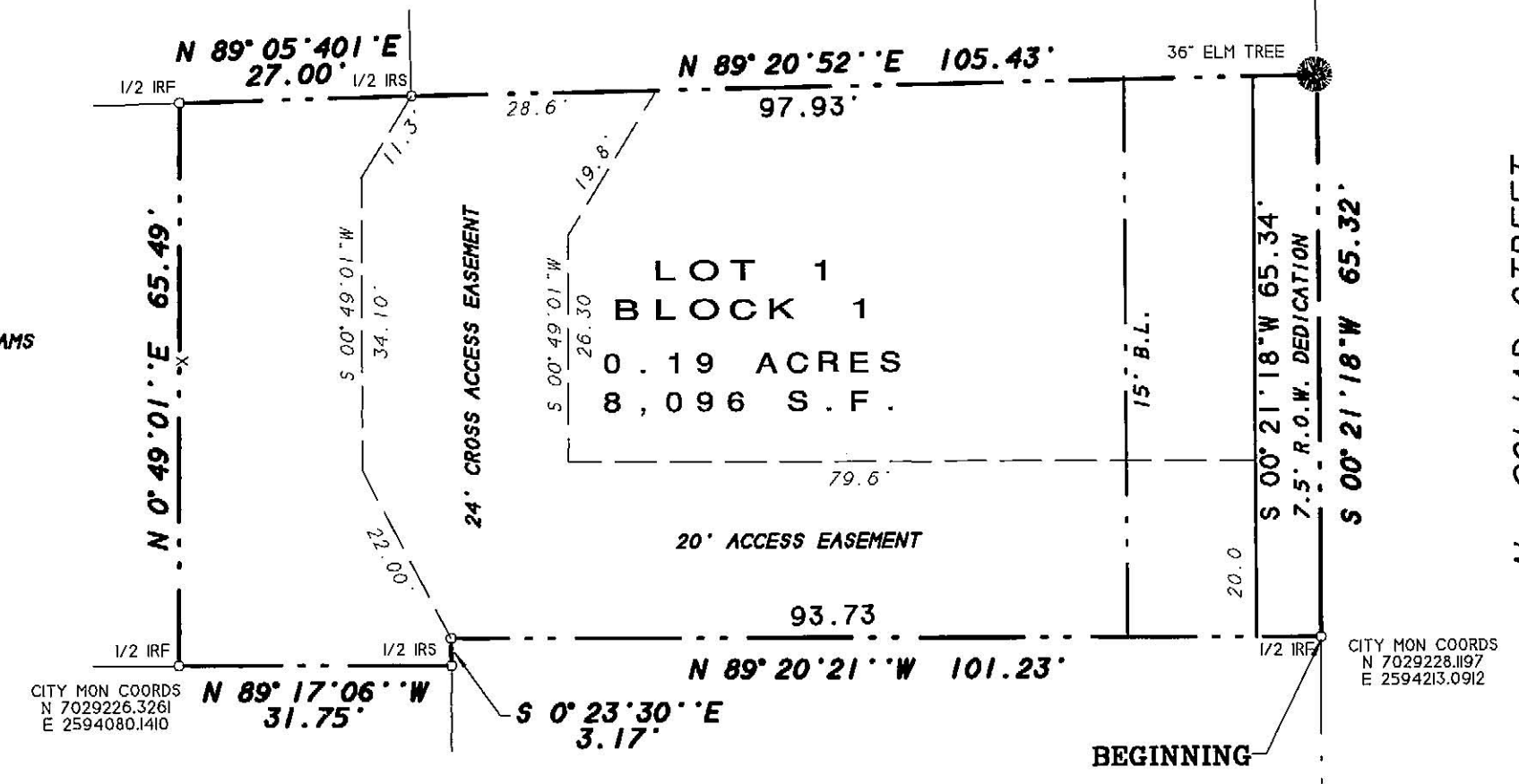

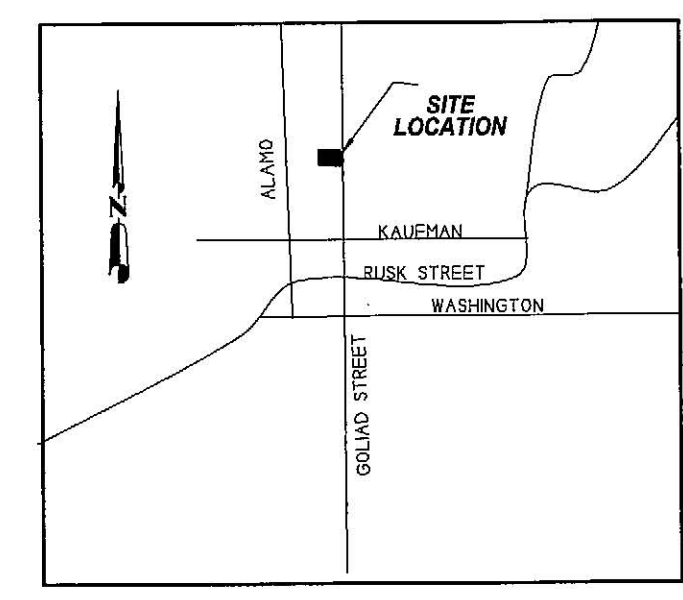
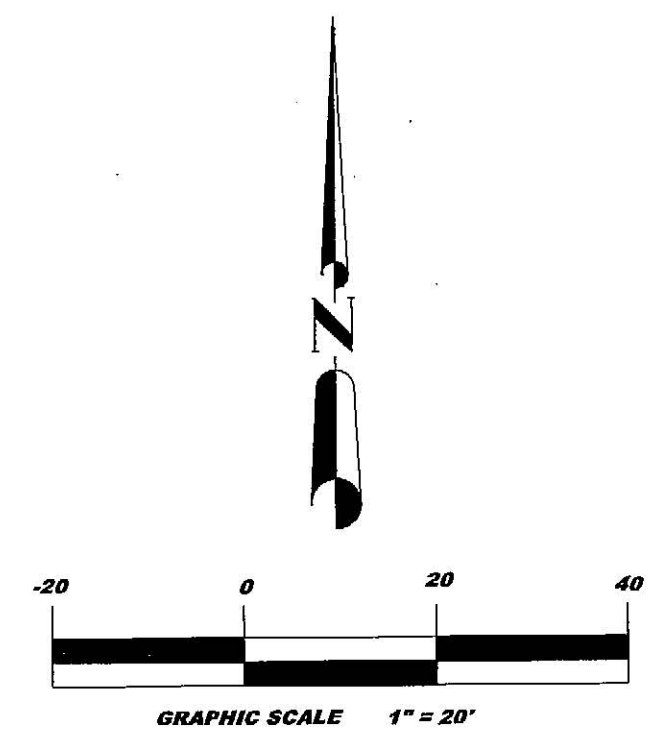

(Public Dedication)

WHEREAS MISTY PHILLIPS, BEING THE OWNER OF A TRACT OF land in the B.F. BOYDSTUN SURVEY, ABSTRACT NO. 14, County of Rockwall, State of Texas, said tract being described as follows:

All that certain lot, tract or parcel of land situated in the B.F. BOYDSTUN SURVEY, ABSTRACT NO. 14, City of Rockwall, Rockwall County, Texas, and being all of that 0.20 acres tract of land as described in a Warranty deed from Deborah A. Crump to Cedo Rakich and wife, Julia Rakich, dated February 8, 1998 and being recorded in Volume 1332, Page 141 of the Real Property Records of Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at 1/2" iron rod found for corner in the West right-of-way line of State Highway 205 N. Goliad Street (50 R.O.W.) at the Southeast corner of said Rakich tract and the Northeast corner of a 0.230 acres tract of land as described in a Deed from Leonard Hamilton and Merita Harper to Dennis and Peggy Irby, as recorded in Volume 177, Page 740 of the Real Estate Records of Rockwall County, Texas;

THENCE N. 89 deg. 20 min. 21 sec. W. along the North line said Irby tract, a distance of 101.23 feet to a fence corner post found for corner at the Northwest corner of same;

THENCE S. 00 deg. 23 min. 30 sec. E. a distance of 3.17 feet to a 1/2" iron rod with yellow plastic cap stamped "R.S.C.I. RPLS 5034" set for corner at the Northeast corner of a tract of land as described in a Deed to James L. Moore, as recorded in Volume 2667, Page 42 of the Real Property Records of Rockwall County, Texas;

THENCE N. 89 deg. 17 min. 06 sec. W. along the North line of said Moore tract, a distance of 31.75 feet to a 1/2" iron rod found for corner at the Southeast corner of a 0.12 acres tract as described in a Deed from Tony and Cruz Williams to RDT Enterprises, as recorded in Volume 1347, Page 178 of the Real Property Records of Rockwall County, Texas;

THENCE N. 00 deg. 49 min. 01 sec. E. along the East line of said RDT Enterprises tract, a distance of 65.49 feet to a 1/2" iron rod found for corner at the Northeast corner of same;

THENCE N. 89 deg. 05 min. 01 sec. E. a distance of 27.00 feet to a 1/2" iron rod with yellow plastic cap stamped "R.S.C.I. RPLS 5034" set for corner at the Southwest corner of a tract of land as described in a Deed from B.D. Willess, Jr. and Doris Willess to Richard S. Wimpee and Theresa Wimpee, as recorded in Volume 490, page 293 of the Real Property Records of Rockwall County, Texas;

THENCE N. 89 deg. 20 min. 52 sec. E. along the South line of said Wimpee tract, a distance of 105.43 feet to a 36" elm tree found for corner in the West right-of-way line of State Highway 205 N. Goliad Street at the Southeast corner of said Wimpee tract and the Northeast corner of said Rakich tract;

THENCE S. 00 deg. 21 min. 18 sec. W. along said right-of-way line, a distance of 65.32 feet to the POINT OF BEGINNING and containing 0.20 acres of land.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

I the undersigned owner of the land shown on this plat, and designated herein as PHILLIPS OFFICE ADDITION, an Addition to the City of Rockwall, Texas and whose name is subscribed hereto, hereby dedicated to the use of public forever all streets, alleys parks water courses, drains, easements and public places thereon shown on the purpose and consideration therein expressed. I further certify that all other parties who have a mortgage or lien interest in the subdivision have been notified and signed this plat.

I understand and do hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same.

I also understand the following;

1. No buildings shall be constructed or placed upon, over, or across the utility easements as described herein.
2. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective system on any of these easement strips; and any public utility shall at all times have the right of ingress or egress to, from and upon the said easement strips for purpose of construction, reconstruction, inspecting, patrolling maintaining, and either adding to or removing all or part of their respective system without the necessity of, at any time, procuring the permission of anyone.
3. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasional by the establishment of grade of streets in the subdivision.
4. The developer and subdivision engineer shall bear total responsibility for storm drain improvements.
5. The developer shall be responsible for the necessary facilities to provide drainage patterns and drainage controls such properties within the drainage area are not adversely affected by storm drainage from the development.
6. No house dwelling unit, or other structure shall be constructed on any lot in this addition by the owner or any other person until the developer and/or owner has complied with all requirements of the Subdivision Regulations of the City of Rockwall regarding improvements with respect to the entire block on the street or streets on which property abuts, including the actual installation of streets with the required base and paving, curb and gutter, water and sewer, drainage structures, storm structures, storm sewers and alleys, all according to the specifications of the City of Rockwall; or

Until an escrow deposit, sufficient to pay for the cost of such improvements, as determined by the city's engineer and/or city administrator, computed on a private commercial rate basis, has been made with the city secretary, accompanied by an agreement signed by the developer and/or owner authorizing the city to make such improvements at prevailing private commercial rates, or have the same made by a contractor and pay for the same out of the escrow deposit, should the developer and/or owner fail or refuse to install the required improvements within the time stated in such written agreement, but in no case shall the City be obligated to make such improvements itself. Such deposit may be used by the owner and/or developer as progress payments as the work progresses in making such improvements by making certified requisitions to the city secretary, supported by evidence of work done; or

Until the developer and/or owner files a corporate surety bond with the city secretary in a sum equal to the cost of such improvements for the designated area, guaranteeing the installation thereof within the time stated in the bond, which time shall be fixed by the city council of the City of Rockwall.

I further acknowledge that the dedications and/or exaction's made herein are proportional to the impact of the subdivision upon the public services required in order that the development will comport with the present and future growth needs of the City; I, my successors and assigns hereby waive any claim, damage, or cause of action that I may have as a result of the dedication of exaction's made herein.

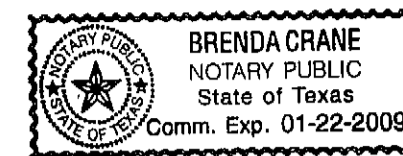
