


LOCATION MAP

OWNERS CERTIFICATE

WHEREAS Gifco Properties, Inc. is the owner of a tract of land in the City of Rockwall, Texas, described as follows:

BEING a tract or parcel of land situated in the William Flevins Survey, Abstract No. 9, Rockwall County, Texas, and being part of a 36.7137 acre tract of land conveyed to the Gifco Development Corporation by deed recorded in Volume 102, Page 27, Deed Records, Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a point for a corner on the Northwest right-of-way line of F.M. Road 740, said point being located South 31° 23' 41" West 120.19 feet from the most Northerly East corner of said Gifco property, said point also being on a straight curve to the left having a central angle of 3° 00' 36" and a radius of 29.04.79 feet;

THENCE: Around said curve with the Northwest right-of-way line of F.M. Road 740 an arc distance of 152.60 feet to a wood monument for a corner and the point of tangency of said curve;

THENCE: South 30° 12' 02" West with the Northwest right-of-way line of F.M. Road 740 a distance of 32.20 feet to a point for a corner, said point also being the East corner of the David Hogg Subdivision recorded in Volume 4, Page 23 of the Plat Records of Rockwall County, Texas;

THENCE: North 46° 15' 53" West with the Northeast line of said David Hogg Subdivision a distance of 120.00 feet to a point for a corner;

THENCE: North 32° 41' 44" East a distance of 150.00 feet to a point for a corner;

THENCE: South 56° 47' 21" East a distance of 152.45 feet to the Point of Beginning and Containing 0.703 Acres of Land.

WHEREAS, Jim Toler and Company, is the owner of a tract or parcel of land situated in the Malcom Barksdale Survey, Abstract No. 11, Rockwall County, Texas, and being part of that certain 11.25 acre tract of land conveyed to the City of Dallas by Margaret Buchanan, et al., by deed recorded in Volume 81, Page 542, Deed Records, Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at an iron rod at the Southwest corner of said 11.25 acre tract of land, said point being at the intersection of the Northwest line of I.H. 30 and the Southeast line of the M.K.T. Railroad;


THENCE: North $57^{\circ} 10' 45''$ East with said railroad a distance of 417.92 feet to an iron rod;

THENCE: Along the arc of said curve whose chord bears South $64^{\circ} 04' 47''$ West an arc distance of 916.68 feet to the Point of Beginning and containing 1.123 Acres of land.


