WHEREAS, Soroptimist International of Rockwall, being the owners of a tract of land in the County of Rockwall, State of said tract being described as follows:

BEING, a tract of land situated in the R. Ballard Survey. Abstract No. 29, Rockwall County, Texas, and being part of Track as recorded in Volume 168, Page 532, Deed Records of Rockwall County, Texas, and being more particularly described as follow BEGINNING, at a point in the center of Aluminum Plant Road, said point being the Northwest corner of Tract One, a 12" iron found for corner;

THENCE, along the center of Aluminum Plant Road, the following:

N. 88° 55' 48" E., a distance of 119.00 feet to a $\frac{1}{2}$ 0 iron stake found for corner;

S. 49° 00' 36" E., a distance of 521.92 feet to a 5" iron stake found for corner;

THENCE, N. 82° 04' 44" W., leaving the center of Aluminum Plant Road, a distance of 149.44 feet to a 5" iron stake for corner;

THENCE, S. 1° 33' 50" W.s. a distance of 59,06 feet to a 5" iron stake found for corner;

THENCE, N. 88° 26' 10" W., a distance of 319.56 feet to a 3" iron stake for corner;

THENCE, N. 6° 45' 54" W., a distance of 372.44 feet to the PLACE OF BEGINNING and containing 2.539 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That, Soroptimist International of Rockwall, being owners, do hereby adopt this plat designating the herein described property as SOROPTIMIST ROCKWALL CHILDRENS HOME, to the City of Rockwall. Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon and does hereby reserve the right-of-way and easement strips shown on this plat for the purpose stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance of efficiency of their respective systems on any of the right-of-way and easement strips; and any public utility shall have the right of ingress and egress to, from and upon the said right-of-way and easement strips for the purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grades of streets in this addition. (A) It shall be the policy of the City of Rockwall to withhold issuing building permits until all streets, water, sewer and storm drainage systems have been accepted by the City. (B) The approval of a plat by the City does not constitute any representation, assurance or guarantee by the City of the adequacy and availability of water for personal use and fire protection within such plat.
