BEGINNING at an iron rod set at the intersection of the North line of Washington Street with the East line of Clark Street; THENCE: North 2° 44' 24" West a distance of 262.85 feet with said line of Clark Street to an iron rod set for a corner, said iron rod being on the South line of that tract of land conveyed to Robert L. THENCE: North 0° 02' 44" West a distance of 200.00 feet along the East line of said Peoples tract to an iron rod set for a corner on the South line of Kaufman Street and at the Northeast corner of said Peoples tract and the Northwest corner of said tract described in the above mentioned deed recorded in Volume 31, Page 74;

THENCE: North 0° 35' 03" East passing at 50.00 feet the Southeast corner of that tract of land conveyed to Jack D. James by deed recorded in Volume 134, Page 349, Deed Records, Rockwall County, Texas, and continuing along the East line of said James tract a total distance of 183.69 feet to an iron rod set at the Northeast corner of said James tract;

THENCE: South 89° 35' 07" West a distance of 75.00 feet along the North line of said James tract to an iron pipe found for the Northwest corner of said James tract and on the West line of that tract of land conveyed to Rockwall Independent School District by the above mentioned deed recorded in Volume 45, Page 217;

THENCE: North 0° 24' 10" West a distance of 219.97 feet along the West line of said tract to an iron rod found for its Northwest corner;

THENCE: North 89° 53' 07" East a distance of 100.91 feet along the North line of said tract recorded in Volume 45, Page 217 to an iron rod found for its Northeast corner and the Southeast corner of that tract of land conveyed to Billy Pat Crawford by deed recorded in the Deed Records, Rockwall County, Texas, and on the West line of Epperson Addition, an addition to the City of Rockwall, Texas, and recorded in the Plat Records, Rockwall County, Texas;

THENCE: South 0° 09' 06" East a distance of 15.99 feet along the West line of said addition to an iron rod found at the Southwest corner of said addition and at a Northwest corner of that tract of land conveyed to Rockwall Independt School District by the above mentioned deed recorded in Volume 45, Page 153;

THENCE: South 89° 24' 26" East a distance of 78.55 feet with the South line of said addition and a North line of said tract recorded in Volume 45, Page 153 to an iron rod at the Southeast corner of said addition;

THENCE: North 1° 14 42" East a distance of 274.00 feet along the East line of said addition and the most Northerly West line of said tract recorded in Volume 45, Page 153 to a point for a corner on the Southeast line of State Highway No. 66;

THENCE: North 54° 30' 10" East a distance of 62.40 feet with said Southeast line to a point for a corner;

THENCE: South 1° 14' 42" West a distance of 310.75 feet along the most Northerly East line of said tract recorded in Volume 45, Page 153 and the West line of Hays Addition, an unrecorded addition to the City of Rockwall to an iron rod on the South line of said addition and on the South line of Blanche Street, an undedicated roadway, and on the North line of said tract recorded in Volume 45, Page 153;

THENCE: South 0° 00' 04" West a distance of 200.93 feet with the West line of said Payne tract to an iron rod found for the Southwest corner of said Payne tract and the Northwest corner of that tract of land in the name of the City of Rockwall; THENCE: South 0° 26' 53" East a distance of 845.79 feet with the West line of said City of Rockwall tract and along the East line of said Rockwall Independent School District tract to an iron rod found at the intersection of the East line of said Rockwall Independent School District and the West line of said City of Rockwall tract with the existing North line of Washington Street; THENCE: South 82° 22' 25" West a distance of 415.46 feet along said North line of Washington Street to an iron rod set for a corner at an angle point in said North line;

THENCE: South 89° 31' 05" West a distance of 524.90 feet continuing along said North line to the Point of Beginning and Containing 19.108 Acres of Land.

That the Rockwall Independent School District being owner, does hereby adopt this plat designating the hereinabove described property as Rockwall School Addition Number One, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon, and does hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance, or efficiency of their respective system on any of these easement strips; and any public utility shall have the right of ingress or egress to, from and upon the said easement strips for purpose of construction, reconstruction, inspecting, patrolling, maintaining, and either adding to or removing all or part of their respective system without the necessity of at any time procuring the permission of anyone.



WHEREAS, the Rockwall Independent School District is the owner of a tract of land situated in the R. Ballard Survey, Abstract No. 29, City of Rockwall, Rockwall County, Texas, and being part of Rockwall School Addition No. 1, an addition to the City of Rockwall Rockwall School Addition Rockwall Recorded in Volume R. Page 11. Plat Records of Rockwall County as recorded in Volume B, Page 11, Plat Records of Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a 1/2" iron rod set with plastic cap stamped "RPLS 4613" for corner at the intersection of the north line of Washington Street, and the east line of Clark Street;

THENCE N03°25'34"W, with the east line of Clark Street, a distance of 212.81 feet to a 1/2" iron rod set with plastic cap stamped "RPLS 4613" for corner in the south line of Rusk Street;

THENCE N89'00'04"E, with the south line of Rusk Street, a distance of 279.76 feet to a 1/2" iron rod set with plastic cap stamped

THENCE N00°43'54"W, a distance of 250.00 feet to a 1/2" iron rod set with plastic cap stamped "RPLS 4613" for corner in the south line of Kaufman Street;

THENCE S89°00'04"W, with the south line of Kaufman Street, a distance of 55.00 feet to a 1/2" capped iron rod set with plastic cap stamped "RPLS 4613" for corner;

THENCE NOO'43'54"W, a distance of 310.00 feet to a capped 1/2" iron rod set for corner in the north line of Interurban Street;

THENCE S89.55'06"W, with the north line of Interurban Street, a distance of 58.26 feet to a capped 1/2" iron rod set for corner in the east line of Nash Street;

THENCE N00°06'07"W, with the east line of Nash Street, a distance of 196.92 feet to a 1/2" capped iron rod set for corner, said point being the beginning of a curve to the right having a central angle of 49°31′49", a radius of 160.56 feet, a tangent length of 74.07 feet, and a chord bearing N24°39'47"E, 134.52 feet;

THENCE in a northeasterly direction along said curve to the right, and with the east line of Nash Street, an arc distance of 138.80 feet to a 1/2" iron rod set with plastic cap stamped "RPLS 4613" for corner and the beginning of a reverse curve to the left having a central angle of 11°40'31", a radius of 129.45 feet, a tangent length of 13.24 feet, and a chord bearing N43'35'29"E, 26.33 feet;

THENCE in a northeasterly direction along said curve to the left, and with the east line of Nash Street, an arc distance of 26.38 feet to a 1/2" capped iron rod set with plastic cap stamped "RPLS 4613" for corner and the end of said curve, said point

THENCE S01°08'03"E, a distance of 845.81 feet to a 1/2" iron rod set with plastic cap stamped "RPLS 4613" for corner in the aforementioned north line of Washington Street;

THENCE S81°41′15″W, with the north line of Washington Street, a distance of 415.47 feet to a 1/2″ iron rod set with plastic cap stamped "RPLS 4613" for corner;

THENCE S88\*49'55"W, with the north line of Washington Street, a distance of 524.90 feet to the POINT OF BEGINNING and CONTAINING 760,747 square feet, or 17.464 acres of land.

BASIS OF BEARINGS: The bearings shown are derived from Texas WDS RTK Network, Texas State Plane Coordinate System, Nad83, North Central Zone, Nad 83 (CORS96) Epoch 2002.0, vertical positions are referenced using NAVD88 using (GEIOD03).

GENERAL NOTES

It shall be the policy of the City of Rockwall to withhold issuing building permits until all streets, water, sewer, and storm drainage systems have been accepted by the City. The approval of a plat by the City does not constitute any representation, assurance or guarantee that any building within such plat shall be approved, authorized or permit therefore issued, nor shall such approval constitute any representation, assurance, or guarantee by the City of the adequacy and availability for water for personal use and fire protection within such plat, as required under Ordinance 83-54.

## STATE OF TEXAS COUNTY OF ROCKWALL

We, Rockwall Independent School District, the undersigned owner of the land shown on this plat, and designated Lot 1, Block A, Dobbs Elementary Addition to the City of Rockwall, Texas, and whose name is subscribed hereto, hereby dedicate to the use of the public forever, all streets, alleys, parks, water courses, drains, easements, and public places thereon shown for the purpose and consideration therein expressed.

We understand and do hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same. We also understand the following:

- 1. No buildings shall be constructed upon, over or across the utility easements as described herein.
- 2. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance, or efficiency of their respective system on any of these eggement strips; and any respective system on any of these easement strips; and any public utility shall at all times have the right of ingress or egress to, from, and upon the said easement strips for the purpose of construction, reconstruction, inspecting, patrolling, and either adding to or removing all or part of their respective system without the necessity of, at any time, procuring the permission
- The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grade of streets in the subdivision.
- The developer and subdivision engineer shall bear total respon sibility for storm drain improvements.
- 5. The developer shall be responsible for the necessary facilities to provide drainage patterns and drainage controls such that properties within the drainage area are not adversely affected by storm drainage from the development.
- 6. Property owner is responsible for maintaining, repairing, and replacing detention/drainage system.
- 7. No house, dwelling unit, or other structure shall be constructed on any lot in this addition by the owner or any other person until the developer and/or owner has complied with all require ments of the Subdivision Regulations of the City of Rockwall regarding improvements with respect to the entire block on the street or streets on which property abuts, including the actual installation of streets with the required base and paving, curb and gutter, water and sewer, drainage structures, storm structures, storm sewers, and alleys, all according to the specifications of the City of Rockwall; or

Until an escrow deposit, sufficient to pay for the cost of such improvements, as determined by the city's engineer and/or city administrator, computed on a private commercial rate basis, has been made with the city secretary, accompanied by an agreement signed by the developer and/or owner, authorizing the city to make such improvements at the prevailing private commercial rates, or have been made by a contractor and pay for the same out of the escrow deposit, should the developer and/or owner fail or refuse to install the required improvements within the time stated in such written agreement, but in no case shall the City be obligated to make such improvements itself. Such deposit may be used by the owner and/or developer as progress payments as the work progresses in making such improvements by making certified requisitions to the city secretary, supported by evidence of work done, or

Until the developer and/or owner files a corporate surety bond with the city secretary in a sum equal to the cost of such improvements for the designated area, guaranteeing the install—ation thereof within the time stated in the bond, which time shall be fixed by the city council of the City of Rockwall.

We further acknowledge that the dedications and/or exactions made herein are proportional to the impact of the Subdivision upon the public services required in order that the development will comport with the present and future growth needs of the We, our successors and assigns hereby waive any claim, damage, or cause of action that We may have as a result of the dedication of exactions made herein.
