BEGINNING at a point on the West line of Ridge Road (F.M.Road N.740), said point being the Southeast corner of said tract recorded in Volume 139, Page 890 and the Northeast corner of Ellen Edwards Lot, and iron stake for corner;

THENCE, S. 89 deg. 12 min. 07 sec. W., leaving the said West line of Ridge Road, a distance of 261.68 feet to an iron stake for corner;

THENCE, along the East line of a 15 foot alley the following:

N. 1 deg. 22 min. 51 sec. E., a distance of 75.50 feet to an iron stake for corner;

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That, Richard Cullins and JoAnn Cullins, being owner, does hereby adopt this plat designating the herein above described property as CULLINS ADDITION to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon, and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way interfere with construction, maintenance, or efficiency of their respective systems on any of these right-of-way and easement strips: and any public utility shall have the right of ingress and egress to from and upon the said right-of-way and easement strips for purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing allered or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishments of grades of streets in the subdivision.
