WHEREAS, Richard D. Harris is the owner of a tract of land in the County of Rockwall, State of Texas, said tract being described as follows:
BEING, a tract of land situated in the B.F. Boydston Survey, Abstract No. 14, and also being that tract as recorded in Volume 109, Page 606, Deed Records of Rockwall County, Texas, and being more particularly described as follows:
BEGINNING, at a point on the West line of Goliad Street, said point being the Southeast corner of Cain Properties No. 1 an addition to the City of Rockwall, an iron stake for corner;
THENCE, South, along the said West line of Goliad Street a distance of 85.86 feet to an iron stake for corner;
THENCE, N. 88° 20' 17" W., leaving the said West line of Goliad Street a distance of 125.53 feet to an iron stake for corner;
THENCE, N. 1° 39' 43" E., a distance of 100.00 feet to an iron stake for corner;
THENCE, S. 74° 18' 06" E., a distance of 58.43 feet to an iron stake for corner;
THENCE, S. 88° 20' 17" E., a distance of 66.36 feet to the PLACE OF BEGINNING and containing 0.254 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:
That, Richard D. Harris, being owner does hereby adopt this plat designating the herein above described property as Richard Harris Subdivision No. 4, to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective systems on any of the right-of-way and easement strips, and any public utility shall have the right of ingress and egress to, from and upon the said right-of-way and easement strips for the purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishments of grades of streets in this addition
