OWNERS CERTIFICATE

WHEREAS, Richard Harris, being the owner of a tract of land in the County of Rockwall, State of Texas, said tract being described as follows:

BEING, a tract of land situated in the R. Ballard Survey, Abstract No. 29, City of Rockwall, Rockwall County, texas, and also being part of a 0.535 acre tract recorded in Volume 130, Page 545, and that tract as recorded in Volume 204, Page 303, Records of Rockwall County, and being more particularly described as follows:

BEGINNING, at a point on the East line of High School Lane, said point being the Southwest corner of said tract recorder in Volume 204, Page 303, an iron stake for corner.

THENCE, along the East line of High School Lane, the following:

N. 4" 35' 24" E., a distance of 66.80 feet to a point for corner.

N. 1' 18' 25" E., a distance of 84.86 feet to an iron stake for corner.

THENCE, S. 83° 54' 39" E., leaving the said East line of High School Lane, a distance of 40.47 feet to an iron stake fo

THENCE, S. 67" 03' 28" E., a distance of 152.66 feet to an iron stake for corner.

THENCE, S. 4° 22° 37" E., a distance of 8.42 feet to an iron stake for corner. THENCE, S. 5° 58' 24" W., a distance of 69.54 feet to an iron stake for corner.

THENCE, S. 86' 49' 33" W., a distance of 181.79 feet to the PLACE OF BEGINNING and containing 0.498 acres of land.

## NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

THAT, Richard Harris, being owner does hereby adopt this plat designating the herein described property as Richard Harris Subdivision No. 6 to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever, the streets and alleys shown thereon and does hereby reserve the right-of-way and easement strips shown on this plat for the purpose stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintainance or efficiency of their respective systems on any of the right-of-way and easement strips and any public utility shall have the right of ingress and egress to, from and upon the said right-of-way and easement strips for the purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grades of streets in this addition. (A) It shall be the policy of the City of Rockwall to withhold issuing building permits until all streets, water, sewer and storm drainage systems have been accepted by the city. (B) The approval of a plat by the City does not constitute any representation, assurance, or guarantee that any building within such plat shall be approved, authorized or permit therefore issued not shall such approval constitute any representation, assurance or guarantee by the City of the adequacy and availability of water for personal use and fire protection within such plat.
