

OWNERS CERTIFICATE

WHEREAS. First Continental Enterprises Inc. is the owner of a tract of land in the County of Rockwall. State of lexas, said tract being described as follows:

BEING a tract of land situated in the S.S.McCurry Survey, Abstract No. 146, City of Rockwall, Rockwall County, Texas, and further being part of a 37.5 acre tract designated as Sixth tract, as conveyed to First Continental Enterprises Inc., as recorded in Volume 101, Page 863, Deed Records, Rockwall County, Jexas, and being more particularly described as follows;

BEGINNING at a point in the centerline of Quail Run Road and on the North line of the 5.5. McCurry Survey, Abstract No. 146, said point being the Northwest corner of said sixth tract, an iron stake found for corner:

THENCE: 5. 88 dec. 26 min. E., along the North line of the S.S.McCurry Survey, and the centerline of Quail Run Road, a distance of 500.00 feet to an iron stake for corner:

THENCE, S. 1 deg. 88 min. 42 sec. W., leaving the said centerline of Quail Run Road, a distance of 450.00 feet to an iron stake for corner;

THENCE, N. 88 deg. 26 min. W. a distance of 500.00 feet to a tron stake for corner;

THENCE, N. 1 deg. O8 min. 42 sec. E., a distance of 450.00 feet to the PLACE OF BEGINNING and containing 5.465 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That, FIRST CONTINENTAL ENTERPRISES, INC., being owner, does hereby adopt this plat desingating the herein above described property as L.L.LEONARD ADDITION to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon, and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance, or efficiency of their respective systems on any of these to, from and upon the said right-of-way and easement strips; and any public utility shall have the right of incress and egress to, from and upon the said right-of-way and easement strips for purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the parmission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishments of grades of streets in this scholusion.
