OWNERS CERTIFICATE

WHEREAS, Ronald G. and Mary E. Melton are the owners of a tract of land in the County of Rockwall, State of Texas, said tract being described as follows:

BEING a tract of land situated in the R. Ballard Survey, Abstract No. 29, City of Rockwall, Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a point on the East line of Nash Street, said point being South, a distance of 56.50 feet from the point of intersection of the Southeast line of Williams Street (old highway 66) with the East line of Nash Street, an iron stake for corner:

THENCE, 5, 87 dag. 04 min. 56 sec. East, leaving the said East line of Nash Street, a distance of 200.25 feet to an iron stake for corner;

THENCE, South, a distance of 88.90 feet to an iron stake for corner:

THENCE, S. 89 deg. 27 min. 13 sec. W., a distance of 200.00 feet to a point on the East line of Nash Street, an iron stake for corner;

THENCE, North, along the said East line of Nash Street, a distance of 101.00 feet to the PLACE OF BECINNING and containing 0.436 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That, Ronald G. and Mary E. Melton, being owners, does hereby adopt this plat designating the herein above described property as MELTON ADDITION. to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon, and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction. maintenance, or efficiency of their respective systems on any of these right-of-way and easement strips: and any public utility shall have the right of ingress and egress to, from and upon the said right-of-way and easement strips for purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at anytime procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grades of streets in this subdivision.
