STATE OF TEXAS COUNTY OF ROCKWALL

Whereas, Rockwall Joint Venture is the owner of a 48.05 acre tract or parcel of land situated in the City and County of Rockwall, Texas, a part being out of the B. F. Boydstun Survey, Abstract No. 14, said part being a portion of the same 85,873 acre tract of land convoyed to H. L. Williams by deed recorded in Volume 51, Pres 397, and a part being out of two tracts of land in the J. H. B. Jories Survey, 124, one tract being conveyed from Dickerson to R.S. Folsom by deed rec; ume 100, Page 677, and one tract being conveyed from W.F. Barrow, Jr., to R.S. H Q som by deed recorded in Vol., 102, Page 403, Deed Records, Rockwall County, Texas and being more particularly described as follows:

OWNERS CERTIFICATE

BEGINNING at an iron pin for a corner, said point being the most Northwesterly corner of Highland Hills Addition to the City of Rockwall recorded in Volume 2, Page 25, Plat Records, Rockwall County, Texas;

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS: Thet, Rockwall Joint Venture being owner does hereby adopt this plat designating the hereinabove described property as Northshare Phase One, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown therean, and does hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same. Any public utility shall have the right, to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective system on any of these easement strips; and any public utility shall have the right as ingress or egress to, from and upon the said easement strips for purpose of construction,

reconstruction, inspecting, patroling, maintaining, and either ddding to or removing all or part of their respective systems without the necessity of, at any time, procuring the permission of anyone.
