SMARTT BY DEED RECORDED IN VOLUME 105, PAGE 121, AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING AT THE NORTH CORNER OF GOLDENCREST ADDITION, AN ADDITION TO THE CITY OF ROCKWALL, RECORDED IN SLIDE B, AT PAGE 383, PLAT RECORDS OF ROCKWALL COUNTY, TEXAS, SAID POINT ALSO BEING THE WEST CORNER OF SAID HENRY S. MILLER TRACT;

THENCE SOUTH 44 DEGREES 49 MINUTES 25 SECONDS EAST A DISTANCE OF 69.17 FEET TO A 1/2 INCH IRON ROD SET FOR THE POINT OF BEGINNING, SAME POINT ALSO BEING THE POINT OF A NONTANGENT CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 14 DEGREES 22 MINUTES 47 SECONDS, A RADIUS OF 766.69 FEET, AN ARC LENGTH OF 192.42' AND WITH A CHORD BEARING AND DISTANCE OF NORTH 37 DEGREES 37 MINUTES 31 SECONDS EAST A DISTANCE OF 191.91 FEET;

THENCE ALONG SAID CURVE TO THE RIGHT AND WITH THE SOUTHEAST RIGHT-OF-WAY LINE OF YELLOWIJACKET LANE AN ARC DISTANCE OF 192.42 FEET TO A 1/2 INCH IRON ROD SET AT THE POINT OF TANGENCY;

THENCE NORTH 44 DEGREES 51 MINUTES 34 SECONDS EAST CONTINUING ALONG THE THE SOUTH RIGHT-OF-WAY OF YELLOWLACKET LANE, A DISTANCE OF 659.64 FEET TO A 1/2 INCH IRON ROD SET FOR A CORNER:

THENCE SOUTH 44 DEGREES 39 MINUTES IT SECONDS EAST, DEPARTING THE SOUTHEAST RIGHT-OF-WAY LINE OF YELLOWJACKET LANE A DISTANCE OF 788.14 FEET TO A 1/2 INCH IRON ROD SET FOR A CORNER:

THENCE SOUTH 36 DEGREES 28 MINUTES 47 SECONDS WEST, A DISTANCE OF 827.07' FEET TO A 1 / 2 INCH IRON ROD SET FOR A CORNER, SAME POINT BEING IN THE NORTHEAST RIGHT-OF-WAY LINE OF KYLE DRIVE:

THENCE NORTH 44 DEGREES 49 MINUTES 25 SECONDS WEST, ALONG THE NORTHEAST RIGHT-OF-WAY LINE OF KYLE DRIVE A DISTANCE OF 638.48 FEET TO A 1/2 INCH IRON ROD SET AT A POINT OF CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 15 DEGREES 27 MINUTES 07 SECONDS, A RADIUS OF 880.00 FEET, AND A LENGTH OF 228.84 FEET;

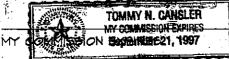

I FURTHER CERTIFY THAT ALL OTHER PARTIES WHO HAVE A MORTGAGE OR LIEN INTREST IN THE ROCKWALL PLACE APARTMENTS SUBDIVISION HAVE BEEN AND SIGNED THIS

I UNDERSTAND AND DO HEREBY RESERVE THE EASEMENT STRIPS SHOWN ON THIS PLAT FOR THE PURPOSES STATED AND FOR THE MUTUAL USE AND ACCOMMODATION OF ALL UTILITIES DESIRING TO USE SAME, I ALSO UNDERSTAND THE FOLLOWING:

- I. NO BUILDINGS SHALL BE CONSTRUCTED OR PLACED UPON, OVER, OR ACROSS THE UTILITY EASEMENTS AS DESCRIBED HREREIN.
- 2. ANY PUBLIC UTILITY SHALL HAVE THE RIGHT TO REMOVE AND KEEP REMOVED ALL OR PART OF ANY BUILDING, FENCES, TREES, SHRUBS OR OTHER GROWTHS OR IMPROVEMENTS WHICH IN ANY WAY ENDANGERS OR INTERFERES WITH CONSTRUCTION, MAINTENACNCE OR EFFICIENCY OF THEIR RESPECTIVE SYSTEM ON ANY OF THESE EASEMENT STRIPS, AND ANY PUBLIC UTILITY SHALL AT ALL TIMES HAVE THE RIGHT OF INGRESS OR EGRESS TO, FROM AND UPON THE SAID EASEMENT STRIPS FOR PURPOSE OF CONSTRUCTION, RECONSTRUCTION, INSPECTING, PATROLLING, MAINTAINING, AND EITHER ADDING TO OR REMOVING ALL OR PART OF THEIR RESPECTIVE SYSTEM WITHOUT THE NECESSITY OF, AT ANY TIME, PROCURING THE PERMISSION OF ANYONE.
- 3. THE CITY OF ROCKWALL WILL NOT BE RESPONSIBLE FOR ANY CLAIMS OF ANY NATURE RESULTING FROM OR OCCASIONED BY THE ESTABLISHMENT OF GRADE OF STREET IN THE
- 4. THE DEVELOPER AND SUBDIVISION ENGINEER SHALL BEAR TOTAL RESPONSIBILITY FOR STORM DRAINAGE IMPROVEMENTS.
- 5. THE DEVELOPER SHALL BE RESPONSIBLE FOR THE NECESSARY FACILITIES TO PROVIDE DRAINAGE PATTERNS AND DRAINAGE CONTROLS SUCH THAT PROPERTIES WITHIN THE DRAINAGE AREA ARE NOT ADVERSELY AFFECTED BY STORM DRAINAGE FROM THE DEVELOPMENT.
- 6. NO HOUSE DWELLING UNIT, OR OTHER STRUCTURE SHALL BE CONSTRUCTED ON ANY LOT IN THIS ADDITION BY THE OWNER OR ANY OTHER PERSON UNTIL THE DEVELOPER AND/OR OWNER HAS COMPLIED WITH ALL REQUIREMENTS OF THE SUBDIVISION REGULATIONS OF THE CITY OF ROCKWALL REGARDING IMPROVEMENTS WITH RESPECT TO THE ENTIRE BLOCK ON THE STREET OR STREETS ON WHICH PROPERTY ABUTS, INCLUDING THE ACTUAL INSTALLATION OF STREETS WITH THE REQUIRED BASE AND PAVING, CURB AND GUTTER, WATER AND SEMER, DRAINAGE STRUCTURES, STORM STRUCTURES, STORM SEWERS, AND ALLEYS, ALL ACCORDING TO THE SPECIFICATIONS OF THE CITY OF ROCKWALL: OR

UNTIL AN ESCROW DEPOSIT, SUFFICIENT TO PAY FOR THE COST OF SUCH IMPROVEMENTS, AS DETERMINED BY THE CITY'S ENGINEER AND/OR CITY ADMINISTRATOR, COMPUTED ON A PRIVATE COMMERCIAL RATE BASIS, HAS BEEN MADE WITH THE CITY SECRETARY, ACCOMPANIED BY AN AGREEMENT SIGNED BY THE DEVELOPER AND/OR OWNER, AUTHORIZING THE CITY TO MAKE SUCH IMPROVEMENTS AT PREVAILING PRIVATE COMMERICIAL RATES, OR HAVE THE SAME MADE BY A CONTRACTOR AND PAY FOR THE SAME OUT OF THE ESCROW DEPOSIT, SHOULD THE DEVELOPER AND/OR OWNER FAIL OR REFUSE TO INSTALL THE REQUIRED IMPROVEMENTS WITHIN THE TIME STATED IN SUCH WRITTEN AGREEMENT, BUT IN NO CASE SHALL THE CITY BE OBLIGATED TO MAKE SUCH IMPROVEMENTS ITSELF. SUCH DEPOSIT MAY BE USED BY THE OWNER AND/OR DEVELOPER AS PROGRESS PAYMENTS AS THE WORK PROGRESSES IN MAKING SUCH IMPROVEMENTS BY MAKING CERTIFIED REQUISITIONS TO THE CITY SECETARY, SUPPORTED BY EVIDENCE OF WORK DONE: OR

UNTIL THE DEVELOPER AND/OR OWNER FILES A CORPORATE SURETY BOND WITH THE CITY SECRETARY IN A SUM EQUAL TO THE COST OF SUCH IMPROVEMENTS FOR THE DESIGNATED AREA, GUARANTEEING THE INSTALLATION THEREOF WITHIN THE TIME STATED IN THE BOND, WHICH TIME SHALL BE FIXED BY THE CITY COUNCIL OF THE CITY OF ROCKMALL.
