

THENCE: South 89° 54' 58" East with the South line of Stone Bridge Meadows a distance of 1015,17 feet to the Southeast corner of Stone Bridge Meadows and an iron pipe on the West line of High Ridge Estates as recorded in Volume 3, Page 11, Flat Records, Rockwall County,

THENCE: South 9° 31' 07" East with the West line of High Ridge Estates a distance of 298,03 feet to an iron rod for a corner;

THENCE: South 46° 09' 49" West with the Northwest line of Ridge Road Village No. 2, as recorded in Volume 2, Page 21, Plat Records,
