BEGINNING at a point in the centerline of Quail Run Road, said point being N. 78 deg. 45 min. W., a distance of 105.00 feet from the Northeast corner of W.T.Collina tract, a nail set for corner; THENCE, S. 9 deg. 05 min. 40 sec. W., leaving the said centerline of Quail Run Road, a distance of 200.00 feet to an iron stake set for corner; THENCE, N. 78 deg. 45 min. W., a distance of 95.00 feet to an iron stake set for corner;

THENCE, N. 9 deg. 05 min. 40 sec. E., a distance of 200.00 feet to a point in the centerline of Quail Run Road, a nail set for corner;

THENCE, 5. 78 deg. 45 min. E., along the centerline of Quail Run Road, a distance of 95.00 feet to the PLACE OF BEGINNING and containing 0.436 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:
