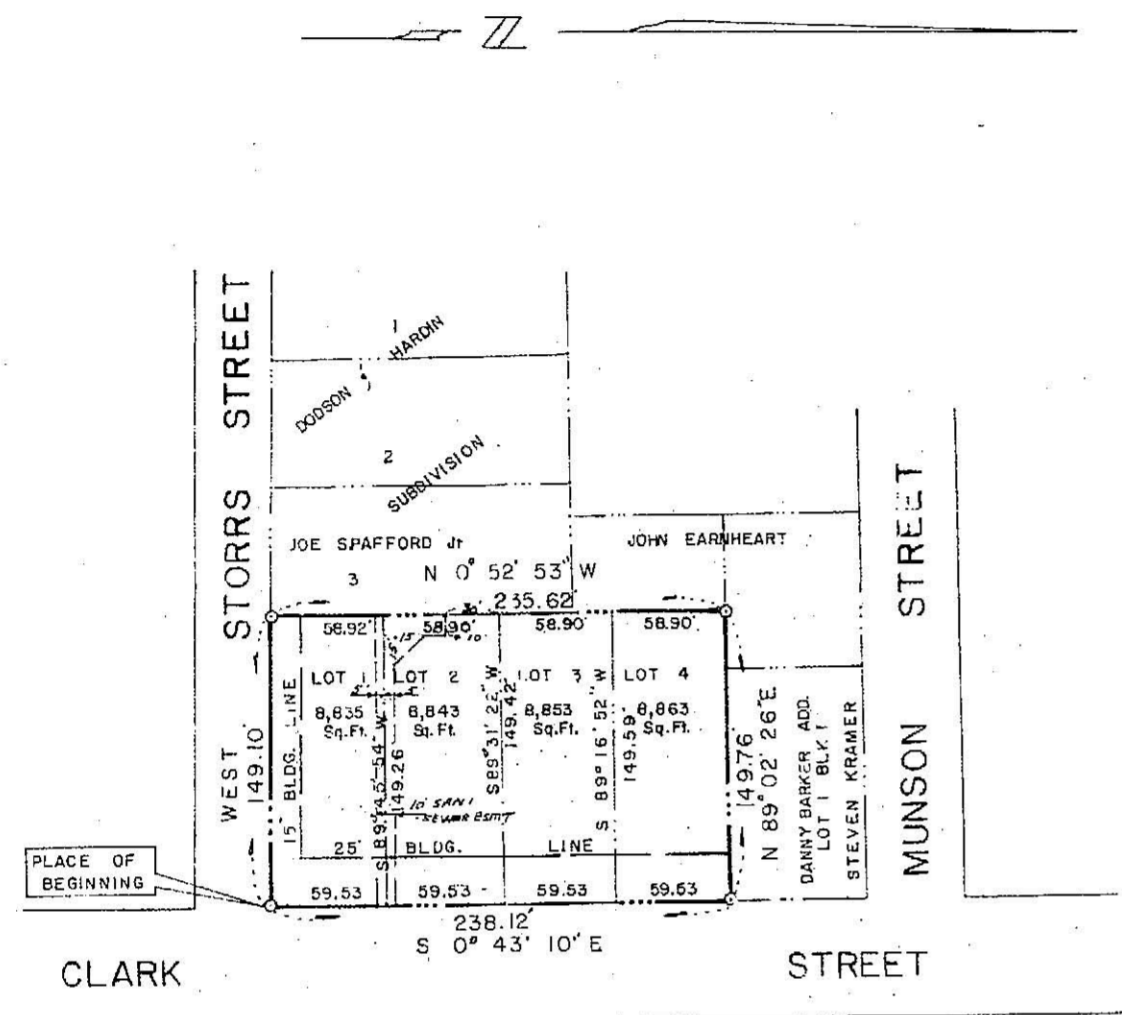
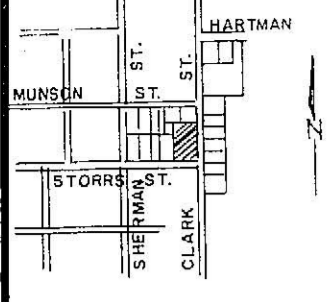


LOCATION MAP

STATE OF TEXAS OWNERS CERTIFICATE
 COUNTY OF ROCKWALL
 WHEREAS, Joe Shields is the owner of a tract of land in the County of Rockwall, State of Texas, said tract being described as follows:
 BEING a tract of land situated in the B.F. Boydston Survey, Abstract No. 14, City of Rockwall, Rockwall County, Texas, and being more particularly described as follows:
 BEGINNING at the point of intersection of the North line of Storrs Street with the West line of Clark Street, an iron stake for corner;
 THENCE, West, along the said North line of Storrs Street, a distance of 149.10 feet to an iron stake for corner;
 THENCE, N. 1 deg. 02 min. 23 sec. E. leaving the said North line of Storrs Street, a distance of 235.62 feet to an iron stake for corner;
 THENCE, N. 89 deg. 02 min. 26 sec. E., a distance of 149.76 feet to a point on the West line of Clark Street, an iron stake for corner;
 THENCE, S. 3 deg. 43 min. 10 sec. E., along the said West line of Clark Street, a distance of 238.12 feet to the PLACE OF BEGINNING and containing 0.313 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:
 That, Joe Shields, being owner does hereby accept this plat designating the herein above described property as SHIELDS ADDITION, to the City of Rockwall, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon and does hereby reserve the right-of-way and easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same, any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective systems on any of these right-of-way and easement strips; and any public utility shall have the right of ingress and egress to, from and upon the said right-of-way and easement strips for the purpose of construction, reconstruction, patrolling, maintaining and either adding to or removing all or part of their respective systems without the necessity of at any time procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grades of streets in the subdivision.
