OWNER'S CERTIFICATE

WHEREAS, Joyce Walters and Anthony Roffino are the owners of a tract of land situated in the B.F. Boydston Survey, Abstract No. 14, Rockwall County, Texas and being that same tract of land described in the deed from Connie Spong Brown and husband, M.H. Brown to Mrs. Franch Spelee dated September 16, 1970 and recorded Volume 92, Page 328, Deed Records Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at an iron rod found at the point of intersection of the South line of St. Mary's Street with the West line of Fannin Street;

THENCE: Along said Westerly line of Fannin Street, South 00° 00' 05" East a distance at 261.90 feet to an iron rod for a corner;

THENCE: Leaving said right-of-way South 88° 47' 10" West a distance of 260.28 feet to an iron rod for a corner;

THENCE: North 00° 00' 05" West a distance of 264.67 feet to an iron pin for a corner set

on the Southerly right-of-way line of St. Mary's Street; THENCE: North 89° 23' 45" East a distance of 260.24 feet to the Place of Beginning and

Containing 1.57286 Acres of Land.

NOW THEREFORE KNOW ALL MEN BY THEST PRESENTS:

THAT the owners JOYCE WALTERS AND ANTHONY ROFFINO do hereby adopt this plat designating the hereinabove described property as 5T. MARY'S PLACE, an addition to the City of Rockwall, Rockwall County, Texas and do hereby dedicate to the public use forever the street shown hereon, and do hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same. Any public utility shall have the right to remove and keep removed all or part of any buildings, fences, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance, or efficiency of their respective system on any of these easement strips; and any public utility shall have the right of ingress or egress to, from and upon the said easement strips for purpose of construction, reconstruction, inspecting, patrolling, maintaining, and either adding to or removing all or part of their respective system without the necessity of at any time procuring the permission of anyone.
